Every student enrolled in a Boston University International Programs internship program is guaranteed an internship while abroad. We provide all students with a professional work experience as a key part of their experience in London. We couldn't call it an internship program otherwise.

Academic Direction

The internship is also a 4-credit course, taken along with other courses to provide a full semester worth of credit (shorter summer-term programs are also available). During the internship phase of the program, students will be required to maintain a daily journal reflecting on their internship experience. By the end of the semester, all students will produce a comprehensive, academic portfolio based on their internship experience, and graded by program faculty members.

"As an intern in the commercial property department of BW I had the opportunity to work with both the commercial property team, which drafts leases, purchase and sale agreements, and negotiates land sales, as well as the litigation team, which deals with issues arising between tenants and landlords and represents clients in court. I edited draft leases, produced schedules of deeds and documents using a system known as digital dictation, researched topics such as court injunctions and case law relating to the purchase and refurbishment of nursing homes, entered deals reports into the network's database, photocopied and bound documents in preparation for presentations, sat in on an inquiry ordered to be conducted by the Secretary of State, and much more."

"Because my firm is so small, I had a large range of responsibilities. I did do some photocopying, faxing, and I did the post every day, but I also did a lot of legal work. The trainee solicitor was only in three days a week, so I helped her with a lot of her cases. By the end of my placement, I was responsible for taking witness statements, drafting briefs to counsel, composing chronologies and summaries for trial, and writing letters to clients for various issues. I also spoke to clients and other solicitors a lot by telephone. All of these tasks are ones that my supervisor would normally have done; they were definitely not menial."

"Serving as a clerk for this firm over the past eight weeks has most certainly been an ineffably rewarding experience. I reflect on my time with the firm not as an onerous requirement or a compulsory service, but as an invaluable learning experience that will carry me through with imparted knowledge for years to come. My daily roles as a clerk included attending court hearings - preliminary hearings, mentions and fixes, plea and case management hearings (PCMH), sentencing at various crown and magistrates' courts throughout London, transcribing exactly what was said in and out of the courtroom, liaising for the defense counsel and solicitor, and meeting with defendants (in holding cells as well as prison) to obtain testimony, evidence and instructions. On two occasions, I acted as a solicitor's representative in trial cases, advising and discussing with counsel strategy and legal procedure, obtaining and serving legal documents, and meeting with judges in chambers, all the while, acquiring a newfound language: legalese.

In the office, I frequently reviewed client files, depositions and evidence on CCTV tapes, listened to recordings of testimony in juxtaposition with written transcripts, worked on financial and administrative projects, and performed a fair-share of clerical duties."
